Buildings account for about 50 percent of resource extraction and consumption and more than 30 percent of all waste generated annually in the European Union. What's more, they simultaneously consume 40 percent of energy and generate 36 percent of greenhouse gas emissions associated with energy generation. Not surprisingly, construction plays a key role in decarbonizing economies, and minimizing the sector's carbon footprint is one of the most cost-effective ways to mitigate the climate crisis.

### Green Transition Can We Afford Not to Go Green?

When technology, the market and competition became religion, the heads of new technology and media companies became missionaries of the New Technoenlightenment. Facebook (Meta) and Google (Alphabet) - organizations with strong cosmologies - "emanated divinity" and instrumentally exploited "sacred" values such as justice. Contemporary ethical catastrophes of big tech and the "twilight of the technogods" mean a crisis of legitimizing their innocence, agency and impunity by secular religion. Faith in their good intentions and neoliberal sacralization of the market is disappearing. The imperative of "measurability of everything" falls, the façade of the language of secular religion is noticed and "false metaphors" are revealed. However, the dawn of a new technouniverse can be seen on the horizon. On the ruins of the "holy alliance" between the user and big tech, new visions and myths are born. No longer "repairing the world", but "improving" man, and sometimes replacing him, as in the case of "generative artificial intelligence".







The participants of the debate will discuss the involvement of the parliaments of Poland, Ukraine and Moldova in the development of economic cooperation, the adoption of the necessary legislation to "stimulate" economic relations at the level of local authorities and specific plans of representatives of specialized parliamentary committees to establish cooperation in the regional triangle. They will also discuss the possibility of cooperation in the implementation of EU energy, infrastructure and investment projects in the Eastern European direction and the joint efforts of the triangle to ensure security and economic stability in Eastern Europe. In particular, the energy component of the interaction will be agreed as the basis for ensuring economic security and further blocking of russian energy in Europe.



Youthful love will change the lives of all four. Their fascination for one woman will not be interrupted by the war or the first two decades of communist rule in Czechoslovakia, although history and politics will put their friendship to the test. The fates of the main characters are interspersed with humorous episodes featuring guest appearances by authentic historical figures such as Miklós Horthy, Jozef Tiso, Klement Gottwald and Ivan Koniev. The best Slovak book of recent years, honoured with the European Prize for Literature 2009 and the SME Readers' Prize. Translated into Czech, Hungarian and Croatian, it was staged at the Slovak National Theatre in 2010.
